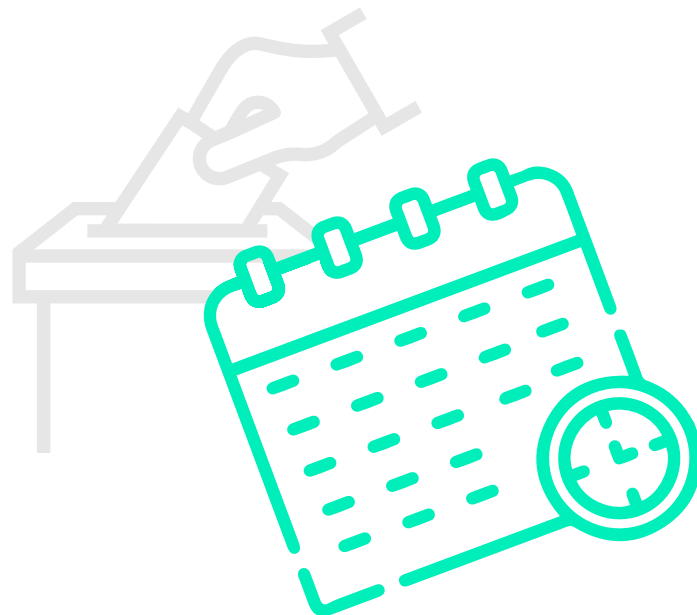

CALENDARIO ELECTORAL ELECCIONES TERRITORIALES 2023



NATIONAL CIVIL REGISTRY RESOLUTION NO. 28229 (OCTOBER 14, 2022)

Whereby the electoral calendar is established for the elections of territorial authorities (governors, mayors, lawmakers, councilors, aediles or members of the local administrative boards) that will be held on October 29, 2023

THE NATIONAL CIVIL REGISTRAR

In exercise of the constitutional and legal powers, especially those established in article 266 of the Political Constitution, numeral 2 of article 26 of Decree Law 2241 of 1986 (Electoral Code), numeral 11 of article 5 of Decree Law 1010 of 2000, and,

WHEREAS

The Article 2 of the Political Constitution states that the “essential purposes of the State are to facilitate the participation of all citizens in the decisions that affect them and in the economic, political, administrative and cultural life of the Nation”.

That Article 266 of the Political Constitution establishes, among other things, to direct and organize the electoral process as the duty of the National Civil Registrar, That In accordance with article 1 of Statutory Law 163 of 1994, the elections of governors, mayors, lawmakers, councilors and aediles or members of local administrative boards will be held on the last sunday of October of the respective year.

That numeral 11 of article 5 of Decree Law 1010 of 2000 gives the National Civil Registry the duty of manage and organize the electoral process and other mechanisms of citizen participation and to prepare the respective electoral calendars.

That Statutory Law 1475 of 2011 establishes dispositions applicable to the elections of territorial authorities.

That in accordance with the corresponding regulations, on October 29, 2023, the elections of governors, mayors, lawmakers, councilors and aediles or members of the local administrative boards will be held, being necessary to establish the electoral calendar.

In accordance with the foregoing,

DECIDES:

ARTICLE ONE: To establish the electoral calendar of the different preclusive stages and activities that must be developed for the elections of governors, mayors, lawmakers, councilors and aediles or members of the local administrative boards, which will be held on October 29, 2023, as follows:

ARTICLE TWO: To communicate this resolution to the President of the Republic, Minister of the Interior, Minister of Finance and Public Credit, Minister of National Defense, Minister of National Education, Minister of Information and Communications Technologies, General Procuracy of the Nation, General Attorney of the Nation, General Comptroller of the Republic, President of the Supreme Court of Justice, President of the Constitutional Court, President of the Council of State, President of the Superior Council of the Judiciary, President of the National Electoral Council, General Commander of the Military Forces, Commander of the National Army, Commander of the Air Force, Commander of the National Navy, General Director of the National Police and Director of Migración Colombia.

ARTICLE THREE: This resolution enters in force upon its publication in the Official Gazette.
